RESOLUTION

Commissioner Sluss offered the following resolution and moved its adoption:

WHEREAS, in accordance with Minnesota Statute 375.51, a Public Hearing was held at 11:00 a.m. on May 8, 2001, to consider adoption of the proposed Crow Wing County Criminal History Background Check Ordinance.

NOW, THEREFORE, BE IT RESOLVED the Board of Commissioners of Crow Wing County, Minnesota, adopts the Crow Wing County Criminal History Background Check Ordinance.

BE IT FURTHER RESOLVED the County Auditor shall publish the Ordinance in its entirety and the Ordinance shall become effective upon publication. The County of Crow Wing ordains that the following Ordinance shall be adopted and shall be effective when published as provided by law:

**CROW WING COUNTY CRIMINAL HISTORY
BACKGROUND CHECK ORDINANCE**

SECTION I: This Ordinance shall be known as the Crow Wing County Criminal History Background Check Ordinance.

SECTION II: Purpose The purpose of this Ordinance is to authorize and empower the Crow Wing County Sheriff's Department to perform criminal history background investigations in various situations in Crow Wing County.

SECTION III: The Crow Wing County Sheriff's Department is authorized to conduct a criminal history background investigation on all applicants for positions, volunteer or otherwise, with non-profit organizations working within Crow Wing County who provide services or are otherwise affiliated with persons under 21 years of age.

SECTION IV: A non-profit organization must first be approved as a qualified non-profit organization prior to the Sheriff conducting a criminal history background check pursuant to Section III above. Once a non-profit organization has been approved, said approval shall remain in full force and effect until rescinded by the Crow Wing County Board. The Crow Wing County Board shall direct the establishment and maintenance of a list of non-profit organizations qualifying for a criminal history background investigation pursuant to Section III.

Which resolution being seconded by Commissioner Dewes was duly adopted, all members voted "AYE".
